### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The graduate is employed in the middle management in the field of horticulture, in work activities associated with the main sectors of horticultural production, it is (flower growing, orcharding, fruit and vegetable growing), especially in reproduction of fruit and ornamental plants, growing flowers, fruits and vegetables growing, landscape gardening and landscape design, flower arranging and making bouquets, storage and processing of horticultural products. After training period leads the horticultural section, or run the private business in the field. Examples of possible jobs: horticultural technician in a specific field or specialisation, agronomist, entrepreneur, merchant, sales representative, etc.
